FG URGED TO LIFT TWITTER'S SUSPENSION TO RESTORE INVESTORS' CONFIDENCE

eighing the economic implications of the suspension Twitter's of operations in Nigeria by the federal government, the Nigeria **Computer** Society (NCS), has called on government to rescind its decision the over



suspension in order to restore investors' confidence and guarantee economic stability. NCS gave the advice in a communique it released recently after a meeting in Lagos.

The federal government had penultimate week, suspended the operations of Twitter in Nigeria for deleting the tweet of President Muhammadu Buhari, which he sent to address the agitators of South-east extraction.

But the NCS in a communique stated: "We appeal to the federal government to lift the suspension forthwith. This will restore investors' confidence and business growth and guarantee economic stability. The 70 per cent youth population of this country will once again have confidence in the digital economic policy being

canvassed bv the present administration.

"This will also guarantee their freedom of expressions as contained in the constitution. After all, 2016 United Nations resolution affirms that the rights that citizens have offline must Coincidentally, this apply online. resolution was co-sponsored bv Nigeria with others. Nigeria Computer Society is ever ready to ensure the coordination of a level playing ground of giant tech for the good welfare and wellbeing of Nigeria People."

President of NCS. Prof. Adesina Nigerian government Sodiya, said might have taken the extreme decision based on cursory analysis of the implications. He, however, said the NCS was convinced very strongly that effect of negative Twitter's the suspension outweighed the gains in Nigeria. He described the negative effects as indeed alarming and huge, and listed them to include: Job losses, unemployment, economics woes and recession, youth restlessness and banditry, insecurity and terrorism, loss brain drain, of ideas and creativity.

He. however. should said Twitter realise that having a dominant share of 200 million people from Nigeria, comes with lot of caution and а decorum.

Sodiya said government should also have a legal framework to register and regulate tech giants and institute a deterrent punitive measures like fines and the likes instead of suspension or outright ban. He promised that NCS continue would to work with government in promoting ethical and professional use of information technology in Nigeria.

NCS, in its communique, observed that Twitter had become the platform for young people and indeed all **Nigerians** their to exercise fundamental right to express and publish opinions.

"They use the platform to complain, and give feedback argue to government and its agencies who in turn, use these to improve their policies and programmes. This is a fundamental point that should be kept in mind as we debate the necessity of this suspension," it added.

The recommended group that government should recognise and value Information Technology society like Nigeria Computer Society and always seek technological advice from the society before taking any drastic information measure on any





UPDATE FROM MINISTRY OF COMMUNICATION AND DIGITAL ECONOMY

DIGITAL ECONOMY: NIGERIA HAS AN ENABLING ENVIRONMENT FOR INVESTMENT TO THRIVE

The Nigerian government says the country has an enabling regulatory environment and policies for digital economic growth.

The Minister of Communications and Digital Economy, Dr. Isa Pantami, gave the assurance at the ongoing Mobile World Congress (MWC), in Barcelona, Spain.

In a presentation titled "Accelerating Digital Transformation – A Case Study of Nigeria", he called on investors to take advantage and harness the potentials of Nigeria's digital economy sector.

Dr. Patanmi while highlighting some of the gains of digital economy in Nigeria's economic growth noted that the digital transformation journey in Nigeria has been demanding but very rewarding.

"The stakeholders and members of the ecosystem are indispensable in the drive to transform the digital landscape of any country. "Having the buy-in and support of the top leadership is critical to sustainable success.

"The support of Mr President has made a lot of difference. We are always ready to partner with sister ministries and



stakeholders" the Minister said. Broadband peneptration

On the issue of broadband penetration, he explained that one of the approaches is the prioritising of broadband penetration and increase in the number of data centers. This is captured in the Nigeria National Broadband Plan 2020-2025.

He noted that some of the challenges faced in the sector were excessive Right of Way charges and vandalisation of critical national infrastructure. Dr. Patanmi also noted that after addressing these challenges "We had unprecedented growth in broadband: over 10% in just over a year, almost 60% drop in the cost of 1GB of data in just over a year. Telecommunications sub sector recorded a growth rate of 15.90% and this was its highest growth the last 10years" he said.

On Indigenous Content Development and Adoption, the Minister affirmed that "We have created the policy environment and now have indigenous companies that are servicing the needs of Nigerians and other African countries. We also developed a policy to promote indigenous content in the Nigerian Telecom industry and it was launched by Mr. President" Pantami said.

Nigeria's digital economy policies

Participants at the Digital Transformation Roundtable which was attended by Ministers from other African countries, DG Smart Africa and other stakeholders was inspired by Nigeria's digital economy success. They expressed willingness to come to Nigeria for a study visit to learn more about the digital economy policies.

Dr. Pantami also held a meeting with the United States of America candidate for the post of Secretary General of International Telecommunications Union (ITU), Mrs Doreen Bogdan-Martin.

Mrs Doreen Bogdan-Martin sought the support of Nigeria through the Minister for the next election and also discussed the Digital Transformation of Africa.

Mrs Bogdan-Martin also commended the effort of Nigeria towards implementing the National Digital Economy Policy and Strategy for a Digital Nigeria.

The Minister also met with the candidate of the Republic of Lithuania for the post of Deputy Secretary General of ITU, Mr Tomas Lamanauskas.

During the meeting, Mr Lamanauskas explained his blueprint for Africa and used the opportunity to seek the support of Nigeria through the Minister for the next election.
